You are agreeing to or have agreed to opt-in to receive non-marketing and marketing text messages from the D&H Tax Service Inc Family of Companies including Skyline Tax Group, including text messages made with an autodialer, at the telephone number(s) that you provide. You are not required to agree to receipt of text messages in order to purchase any product or service from D&H Tax Service Inc, and you may opt-out of these communications at any time (see instructions below).

You also accept and agree to be bound by these SMS Texting Terms and Conditions, our Privacy Policy (located at www.skylinetax.group.) and any other applicable terms and agreements related to your use of D&H Tax Service Inc 's services.

Program Description

D&H Tax Service Inc may use an automatic telephone dialing system ("autodialer") to deliver text messages to you. Text messages may include but not be limited to assistance in completing and/or e-filing your tax return, informational or support purposes, notification of transaction approval, payment reminders and notifications, and servicing your account.

Message Frequency

After opt-in, you may receive an initial confirmation text message. After that, the specific number of text messages may vary depending on how you use the D&H Tax Service Inc services and the types of text messages you registered to receive.

Cost

Message and data rates may apply to each text message sent or received, as provided in your mobile telephone service plan (please contact your mobile telephone carrier for pricing plans), in addition to any applicable roaming charges. D&H Tax Service Inc does not impose a separate fee for sending text messages.

Supported Carriers

Supported carriers may change from time to time, but currently include AT&T, Boost Mobile, T-Mobile, Metro PCS, Verizon Wireless, Sprint, U.S. Cellular, Nextel & Virgin Mobile. T-Mobile is not liable for delayed or undelivered messages.

How to Opt-In

To opt-in to receive this SMS Texting Service, text "START" to 59178 or 78589.

How to Opt-Out

To stop receiving text messages, text "STOP" to 59178 or 78589. When you opt-out, you agree to receive a text confirming that your opt-out choice has been recorded.

Your Mobile Telephone Number

You acknowledge and represent that you are the account holder and/or an authorized user of the mobile telephone number(s) that you provide. You are responsible for notifying us immediately if you change your mobile telephone number.

You agree to indemnify D&H Tax Service Inc in full for all claims, expenses, and damages related to or caused in whole or in part by your failure to notify D&H Tax Service Inc if you change your telephone number, including, but not limited to, all claims, expenses, and damages related to or arising under the Telephone Consumer Protection Act.

Data obtained from you in connection with the text messages may include your name, address, mobile phone number, your mobile service provider's name, and the date, time, and content of your messages. Our use of this information will be in accordance with our Privacy Policy (located at www.skylinetax.group.) Your mobile carrier and other service

providers may also collect data about your mobile device usage, and their practices are governed by their own policies.

Access or Delivery to Mobile Network is Not Guaranteed
